

## **Endowment for Free Methodist Ministries**

## A Gift that Keeps on Giving...

When you establish an endowment with FM Financial (FMF) you can be assured that it will produce income for ministry - forever. Long after you are gone, your gift will still be giving!

#### **How Does an Endowment Work?**

Endowments can be established with present gifts or through planned gifts such as a will or trust. The funds for each endowment are irrevocably deposited with FMF and invested to provide current income and principal growth. A significant portion of the annual income of the endowment is distributed to the ministry or ministries designated by the donor. Such payouts generally begin once the fund exceeds \$7,500. Undistributed income is added to the principal of the endowment, thereby growing the endowment over time.

Additional funds may be added to an existing endowment by you or others at any time to increase the principal and future income to benefit ministry.

#### What Does It Cost?

There are no fees to establish an endowment.

#### **How Do I Get Started?**

If you want to establish an endowment as a part of your estate plan you will need to create the endowment declaration while you are living and leave instructions in your will or trust regarding the funding of the endowment. At your death, the appropriate funds will be gifted to FMF and the endowment will become active.

You may also establish an endowment with an outright gift during your lifetime to benefityourlocal church, a new church plant, an educational institution or scholarship, human service ministry, Free Methodist missions, or a host of other ministries. If the endowment is fully funded during your lifetime the income would begin to benefit ministry even while you are still living.
